Good afternoon Dawn and Thea

Many thanks for meeting with myself and Ryan on Monday.

To confirm the discussion, CAB are looking to apply for a grant from the Town Council for the provision of a Friday service at Canolfan Dewi Sant. The Clerk highlighted that the Council do not fund running costs or wages and therefore any application would need to be for the provision as a whole, which would include the advertising etc. The service would need to be for all of the Abergele community and not just for a small section of the community.

It had been suggested by a member that the application is submitted for £10k, the Clerk confirmed that this was a substantial amount for the Town Council's grant budget but to go ahead and apply and the Council can then make the decision based on the applications received.

The Clerk also stated that the Town Council had suggested, following the recent letter with regard to the change in the service provided, if there was anything that the Council could do to ensure that members of the Community are able to access the service, if they are not able to travel to Llandudno for the triage service, with possibly a room at the Town Hall free of

charge. Dawn confirmed that this would be very welcomed. The Clerk confirmed that this could not be detrimental to the service offered at Canolfan Dewi Sant but would be above and beyond to facilitate the change in service provision.

All of the above would subject to approval from the Town Council once received and considered.



I write to you in the hope that the county councillors will react to the points I make. I contacted the town council in 2023 to no avail really, it's as though no one is listening, and points raised are merely discarded.

My wife and I have resided in Abergele since 1983, therefore this has become our hometown and there was a time we felt pride saying we lived here.

Unfortunately, things have gone downhill over the years which is sad; however I realise this is also true in other areas due to the lack of services that were once in place, which the county carried out quite diligently.

Abergele town centre, the heart of this town and community is looking extremely uncared for and has done for a long time. There seems to be litter everywhere on a regular basis, we walked through the town on the evening of the 15th January and it was a mess to say the least. It would be helpful if businesses perhaps took up the gauntlet and picked up litter in front of their premises. There is definitely a lack of litter bins around but then would this solve the issues of litter being everywhere?

Is there a rolling programme in relation to the lampposts installed throughout the high street? Some need their paintwork attending to.

The planted-up garden displays set within the sleepers are falling apart, and I have brought this up previously again to no avail, Why? Surely there is someone who can address these and tidy them up, repair or replace as necessary. There is no point installing such as these if there is no maintenance programme in place.

Drains are constantly blocked throughout the town centre and throughout Abergele, this causes issues when we face high levels of rain, there does not appear to be anything in place where streets and drains are cleared on a regular basis.

Finally I would like to bring up again the despicable, unacceptable state of our roads, not just in Abergele but in general however I will focus on Abergele as this is where I live. I have contacted the council preciously in 2023 about the state of Turnberry Drive and neighbouring roads where potholes just get worse and as we all know this does our vehicles no good whatsoever. The extent of some potholes is dangerous, some are so severe.

I would like please a response from the county councillors with an explanation as to what is being done to address the above (where they have specific responsibilities of course) I do not want to be fobbed off with excuses I want to see some actions that these issues will be rectified before they get worse.

Following a successful bid for UKSPF funding, there is the potential to place a number of re-deployable public space, CCTV cameras across the County.

In order ascertain the initial placement of cameras we need to establish whether infrastructure, power, posts etc. are suitable to deploy cameras in areas not already supported, followed by a Data Protection Impact Assessment (DPIA)

To do this we need relevant, up to date (within six months) data with regard to environmental crime or issues. This can be hard data, anecdotal information, intelligence from officers, colleagues and members of the public. You may also include areas where there may be future or potential risks.

Specific locations, data/information for example may include:

- Dog fouling, littering, accumulations of rubbish, fly tipping, damage to street furniture infrastructure and graffiti.

Please don't include any matters that should have or have been reported directly to police such as thefts, violence, serious anti-social behaviour etc).

Please note:

County Councillors have already been consulted, duplicate submissions will not be taken into consideration.

In submitting information there is no guarantee that a camera will be placed in the location. Each location will be assessed for priority/issues before any camera deployment.
