- 4. If the election is contested the poll will take place on Thursday, 25 May 2023.

Voter Registration

5. Applications to be added to the Register of Electors in order to vote at this election must reach the Electoral Registration Officer, Bodlondeb, Conwy, LL32 8DU by Tuesday, 9 May 2023. Applications can be made online at https://www.gov.uk/register-to-vote.

Postal and proxy voting

- 6. Electors and their proxies should take note that all applications, amendments or cancellations for new and existing postal votes must reach the Electoral Registration Officer, Bodlondeb, Conwy, LL32 8DU by 5pm on Wednesday, 10 May 2023. This includes electors or their proxies who wish to make alterations to their existing arrangements on a permanent basis.
- 7. Applications to appoint a proxy at this election must reach the Electoral Registration Officer, Bodlondeb, Conwy, LL32 8DU by 5pm on Wednesday, 17 May 2023.
- 8. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer by 5pm on Thursday, 25 May 2023. The physical incapacity must have occurred after 5pm, on Wednesday, 17 May 2023. To apply on the grounds of work/service reasons, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday, 17 May 2023.




