As discussed, in our view the most appropriate funding source for S106 money for your post is the Regeneration funds, from the source as detailed below. The amount available has decreased from my previous email (attached) due to the approval of the QR Boxx funding.

As it stands the decision on 23rd May doesn't secure S106 money for the post as the Board doesn't have authority to take decisions on Affordable Housing S106 spend. Once you're able to re-visit the decision, I suggest that this revised source of funding is proposed to the Board.

Hi Mandy,

Apologies for not getting back to you sooner on this. I've looked at what's available and there isn't much at the moment. There is approx. £17k town centre regeneration money available, which I previously suggested as the source for the £10k towards the post.

There is also the ~£8k open space money which was previously released from the 4G pitch project and was recently refused for the pump track. This remains available and, as the Place Plan officer deals in part with open space projects this is a reasonable source of funds.

So between open space and regeneration there is around £25k currently available subject to approval, but of course the more that is used for the post, the less is available to spend on projects. The figures below show the latest balances for these two sources of funding, but as always these exclude any interest accrued since April.

There is also the possibility of additional S106 funds becoming available from new developments, but there is nothing that can be guaranteed at this stage. The St George Rd is yet to have a date set for Planning Committee, so any money from here (if approved) is still some way off.



Wales 'nowhere near' biodiversity target

Wales is not on course to meet a key 2030 biodiversity target amid concerns about dwindling funding and an overreliance on goodwill, a committee heard.

Steve Ormerod, a professor in ecology at Cardiff University, warned Wales' is "nowhere near" a target of protecting 30% of land and sea for nature by 2030.

He said: "This is a very, very significant target. At the moment, we have about 12% of Wales' land surface which is identified for biodiversity – less than half of that is in good condition."

Prof Ormerod, who is deputy chair of Natural Resources Wales, said government funds are shrinking at a time when Wales needs to pick up the pace and increase scale.

"We don't really have cash incentives to make this happen," he said as he gave evidence to a new Senedd climate change committee inquiry on halting and reversing nature loss.

He added that Wales is relying on goodwill and teamwork to hit the "30 by 30" target.

'Critical'

Richard Unsworth, an associate professor of biosciences at Swansea University, said studies show significant degradation of Wales' waterways continues.

He warned: "What's happening on the land is continuing to degrade what is happening in our oceans and with that we have significant threats to biodiversity."

Dr Unsworth emphaised: "We need to pick up the pace in terms of actual marine management and not paper-based marine management – that is the critical thing."

The ecologist told the committee there is a lack of recognition of how degraded Wales' oceans are, with a Bangor University study showing fisheries have been destroyed.

Dr Unsworth stressed that agriculture, one of the biggest drivers of decline in waterways, must be a part of the conversation, saying: "We can't hide from it."

He also called for action to better monitor the impact of offshore wind farms on biodiversity.

'Slipping'

Llŷr Gruffydd, who chairs the climate committee, raised concerns about a "plethora" of strategies, action plans, devolved and non-devolved bodies involved in the field.

"There's so many different moving parts here," he said, warning it feels overly complicated.

Janet Finch-Saudners, the Conservatives' shadow climate change secretary, suggested the Welsh Government may need to conduct a deeper <u>deep dive</u> on biodiversity.

Delyth Jewell, her Plaid Cymru counterpart, focused on the "hotly anticipated" environmental governance bill, questioning whether Welsh ministers understand the urgency required.

Prof Ormerod said: "One of the key things I think we should all take away ... is that biological diversity is slipping through our fingers.

"The nature of Wales and its environmental fabric has changed dramatically."

'Extreme'

Dr Unsworth told the committee that Natural Resources Wales (NRW) is facing extreme funding pressures with more than 250 jobs at risk.

He said: "We can create all the legislation we want but if we're not funding the capacity of NRW as the principal delivering agent .. then we're not going to do anything."

The ecologist warned that marine special areas of conservation are grossly underfunded as he gave evidence to the inquiry on September 18.

Prof Ormerod said financial pressures on NRW could result in a substantial squeeze on monitoring while there is an increasing need given the 30 by 30 target.

He said: "We don't yet fully understand what the outcomes of resource reductions in NRW will be but I think they could be significant in frontline areas such as monitoring."

The ecologist added: "If all we are doing is monitoring the decline of nature that's not always particularly helpful, so I think we could streamline."

'Underfunded'

In a second evidence session with environmental organisations, Annie Smith, head of policy at RSPB Cymru, said the Welsh Government has been quick to commit Wales to targets.

However, she said: "We're developing frameworks, developing approaches but not necessarily seeing the actions being driven yet in the way they need to."

Alex Phillips, policy and advocacy manager at WWF Cymru, echoed Ms Smith's comments, calling for a focus on delivery and concrete improvements

Asked about the Welsh Government's white <u>paper</u> on environmental principles, Mr Phillips raised concerns about a suggestion some headline targets could be weakened.

Chloe Wenman, policy and advocacy manager at the Marine Conservation Society, warned that the marine sector is chronically underfunded.

She said: "When you think about the speed at which things like offshore wind are being pushed forward, nature recovery is not happening at anywhere near the speed."

Context for PAW as WG-funded charity charged with:

- · Planning and Advice helpline
- Training
- Documentation production
- Engagement

Placeplans have been a priority including engagement and production of guidelines, in particular with CCBC

Context for challenges with Placeplans:

- INTEGRATION can be a challenge due to range of organisations with differing aims, range of departments within these with differing remits, resulting in proliferation of plans covering all manner of topics / themes eg Biodiversity plans, Flood plans, Town Council plans, Economic plans etc
- PUBLIC UNDERSTANDING of planning in general (but also an opportunity for engagement)

In theory, Placeplans:

- Have a focus on land-use (or, as confirmed later in the meeting, could have an element of focus on land-use eg a chapter, or one of several "folios", or "appendices")
- Foster engagement, improve relationships, and build knowledge via cross-pollination of information
- Inspire action, and also provide context / framework for actions
- Can serve as a springboard for funding applications

About Placeplans from PAW perspective:

- Local level <u>land-use</u> plan
- Community-led
- <15 year</p>
- CAN be SPG, but must be "in conformity" (eg National Planning Policy -> LDP -> Planning applications)
- CAN serve as a link between LDP and Planning applications eg as Placeplans can sit within this link, either as an extension of the LDP as SPG, and/or provide a "statement of approach" in terms of how the local area responds to planning
- CANNOT introduce new sites to LDP (except perhaps a v small site)
- CAN be topic / theme based (e.g. "Affordable Housing") or site-specific "Land based at...") but must always fit within the planning hierarchy as above (if to be considered in planning, because a Placeplan could be just that, and detach itself from planning altogether (eg "Community plan" or "Neighbourhood Plan" that focuses on events or whatever the community has identified, as these models also have validity in their own right, in different ways)

Context for this Stakeholder Group:

AP asked for:

- The framework to include details about the benefits of being SPG, given that ATC
 was now in a position where we had been the leader, but were now told our plan was
 a "Placemaking Plan", so we were having to re-visit the Placeplan structure /
 elements for inclusion and marry these together with pre-existing priorities, and the
 priorities highlighted in the 2023 mid-term consultation.
- The framework to include suggestions for potential /engagement activities / questions
 if necessary, given that we have a Plan in place and do not wish to start again, but
 also, will need to address some elements that the current Plan does not address,
 with / for the public (ie the disconnect where public have told us what they want so
 we are working to those priorities but the public did not reference planning,
 specifically)
- Templates / tick boxes to support us as laypeople to know that we are doing the appropriate activities / asking appropriate questions / presenting what is required to meet conformity
- Easy-read info for the public ref planning in general

*Other attendees emphasised the holistic approach (with ATC used as an example of what went well) and James, PAW, concurred with this approach (so yes, Place Plan needs to be about land-use, but also will include all manner of things, as long as that land-use element is clear...)

*Shane, CCBC, confirmed to AP that there was documentation aimed at public and he would search for these and send on, and perhaps this could be discussed at a future Placeplan network meeting.

James, PAW, said new documents should be ready mid-November (1st draft only)
