The mural design has not yet been finalised but can be shared when it has



1. Events

- Businesses would like to try and link into events and activities planned for Town not only to maximise benefit but also avoid duplication / competition.
- TC run annual Christmas Window and Christmas card competition question
 was raised around community engagement with the judging of the windows; if
 children / families were part judging it would encourage footfall around the
 town. Mandy / Abby to take back to TC for consideration.
- It was also suggested that an informal 'Art trail' could be set up with entries to the Christmas card competition being displayed in shop windows. This would support the TC competition giving an opportunity for display across town and again encourage footfall.
- Town lights switch on, concert etc 6th November TBC
- Was raised by Abby to encourage all to tag @aberglepensarn so could be shared as appropriate.
- Business agreed 12th December as start of Thursday Christmas Late night trading.
- TC have an events committee which meet to look at events on behalf of full Town Council. Group was reminded that all Town Council meetings are open to the public so anyone can go along to listen.

- It was noted that some event such as Christmas Fayre, Abergele in Bloom are not Town Council events
- Mandy will investigate how businesses can officially get involved with Abergele in bloom.

2. Town & Ward Grants

 Mandy confirmed that the TC do have funding which constituted organisations can apply into this could be an opportunity for Business Forum to collaborate with a local group / organisation for future events and activities.

3. Abergele Noticeboard

- The question re possibility of a physical noticeboard in Town Centre location was raised
- Experience round table indicated that this was not simply process and could be quite expensive project. Member of the group with link to Cartrefi Conwy was going to query if any space / plans for community noticeboard with the community space being planned.

4. Town Council Website - Abergele | Home (abergelepensarn.co.uk)

- An update of the TC website is underway to return it too standard TC focus.
- Following business requests for marketing and promotional support,
 Abergele's Placeplan Committee is pleased to be launching QRBoxx which is
 an easy-to-use, user-driven platform that will showcase "all things Abergele in
 a one-stop-shop", enhancing the appeal of our collective offer, and creating
 more opportunities to "be seen" via cross-promotion. This is being sponsor by
 Abergele TC and will be free to Businesses
- User (businesses, groups, organisations etc) will be able to upload their own details such as business, events etc. Once uploaded on to QRbox they will then be able to share with their own social media etc.
- For next planned forum meeting on 23rd Sept Abby will host event at the Town Hall to talk in more detail about the QRbox and everything it has to offer.

5. Police Engagement

 Abby has spoken to previous contact Simon Keeting who is Partnership Officer, and he has agreed to attend a future forum meeting which may be a good starting point to start looking at some of the concerns raised by businesses such as security tips and support for at risk members of the community.

Was agreed to arrange for Simon to attend future meeting.

6. Abergele PlacePlan committee

- The Town Council would like representative for the Business Forum to sit on the PlacePlan committee. The individual would have to be able to represent views of the wider Business Forum and be available to attend meetings the last Thursday of every month from September.
- Was agreed that any member of the group interesting in being the rep for the forum would attend the next place plan meeting on 26th of September as member of the public so they could get a better understanding of what the meeting covers.

7. AOB

- Business Rates continues to be a major issue for most of the businesses, discussion around lobbying through MP's, AM's and organisation such as FSB.
- Requested that an explanation of business rates be provided AB to action
- Clinic Carpark this area of the carpark is part of the Betsi site so any approach for use of this area would need to be to them. It was also raised that staff for the clinic seemed to be using the main carpark blocking up valuable spaces from shoppers.

Beach of Dreams (Kinetica)

Following a period of growth, the most recent mission is as follows:

"A major interdisciplinary creative programme will see ambitious new participatory art commissions, creative walks and events taking place across the coasts of England, Scotland, Northern Ireland and Wales, and digitally, from 1 May – 1 June 2025.

Beach of Dreams is a platform for celebrating, reflecting and imagining new possible climate futures for our coastlines and planet.

The festival takes place outdoors and in public spaces and is free to attend – everyone is welcome".

Abergele, as a member organisation, is invited to participate in national and regional elements of the festival as follows:

Nationwide Touring - May 1 to June 1 2025.

"An installation of hundreds of pennants, each telling a personal story of our relationship to coast and sea. Together, these form a tapestry of hope and inspiration for our shared future and alongside these everyone can offer their own personal pledge to support the future of our coastal environment".

What does this mean for Abergele in real terms?

- ATC will have a pennant, and this pennant will be included in the installation of 500+ pennants at Bay of Colwyn beach.
- ATC will be invited to "walk in their pennant" and place in the installation
 which will be during Prom Xtra on May 10th (there is capacity to bring the
 pennant to Bay of Colwyn Town Council and join in procession down to
 the beach, or to walk the pennant in direct from our coast, but logistics
 have not yet been sorted, and this will also be dependent on the number of
 people willing and able to walk in the procession)
- ATC will likely be invited to host a stand at the May 10th event in Colwyn Bay, showcasing "what is special / unique" about our stretch of beach suggestion from Events Conwy, who are now part of the network, and offering their support to us, is to highlight the below: "Pensarn is a protected area, designated as a Site of Special Scientific Interest (SSSI). It lies northwest of Abergele and is a stunning pebble beach with a large vegetated shingle bank. Formidable maritime plants persevere to make it their home. Shingle beaches are dynamic and blustery places, loved by wind surfers and dog walkers, but they are also important habitats. The creatures that live here have to be incredibly hardy as they suffer from constant changes to their habitat.
 Pensarn is a unique shingle beach. Its shore is just sheltered

enough that storm waves cannot reach it, allowing enough stability

for maritime plants to grow. A wonderful place to go shell hunting or bird watching" - CCBC

- Pennant creation guidelines have been further developed and now require community engagement activities during which people will be asked to write 300 words about why "their stretch of beach" is special to them, what memories the beach evokes, and share stories of their beach memories and experiences. Members to also feed into groups and complete write up etc.
- These written submissions will be used by the artists who will be creating our pennant, based on two photographs of our stretch of beach, one wide shot, and one close-up.
- First deadline for submission is October 15th, second is February 25th, which is more feasible considering that the Conwy Network has not officially launched, and also the required community engagement sessions
- Submissions received by the second deadline will be returned by end of April in time for the art installation.

Sound Commission with TAPE and Bay of Colwyn Town Council

What is this about and what does it mean for Abergele?

- Colwyn Bay is a lead partner in Beach of Dreams, with ten pennants, and as such, they have been assigned
 - o an artist to work with them
 - o a question to ask / explore
- Colwyn Bay's artist is Jason Singh
 Jason's life and work is rooted in listening. He follows a multi-sensory and
 cross-species approach to sound and music. His creative output is an
 exploration of the natural world, voice and a wide range of music
 technologies. Works includes live performance, immersive installations, studio
 recordings, music for film and theatre, deep listening and well being
 experiences, sound walks, broadcasts, music workshops, podcasts,
 soundtapes and immersive DJ sets.
 - Collaborations and commissions include a diverse range of organisations and artists including BBC, Yorkshire Sculpture Park, V&A Museum, Earthshot Prize, WOMAD, Kew Gardens, Chester Zoo, SONOS, Luke Jerram, BFI, Celtic Connections, RNLI, National Trust, Tate Britain, Nitin Sawhney, George Ezra, Big Narstie, Yazz Ahmed, Shabaka Hutchings, Sebastian Rochford, Leafcutter John, Graham Massey (808 State), Natacha Atlas, Sarathy Korwar, Talvin Singh and Rokia Traore
- Jason will be exploring the question, "What can we not hear?" and using sensitive microphones, he will record sounds of nature, including those that are imperceptible to the human ear. Members to feed into groups and solicit participation in this.

Jason will be visiting North Wales on October 22nd – 27th and Abergele may
be able to have him visit to make recordings. Whilst this might be ideal for
schools, they will be on half term, so if there are other community groups that
work with / in nature, they may wish to be included.

CONSIDERATIONS

Bay of Colwyn, as a Beach of Dreams partner, has invested significant funds in this event, and this event will form a major part of their annual events programme

Bay of Colwyn Town Council has proposed a joint funding bid to secure funding for local adjunct events in the lead up to May 2025

Abergele's activities in relation to Beach of Dreams must be proportionate, and localised, so the following is proposed:

- Marketing and Promotion activities with Events Conwy's support, about Beach of Dreams and our coastline's unique features eg vegetation
- Awareness raising activities / community engagement sessions for the pennant creation x 3, delivered by Placeplan Officer eg schools (with Members also feeding into groups and completing the 300 word write-up)
- Potential visit from Jason Singh to record sounds x 1/2 day, with invitation from Jason for the public to submit their own sound recordings or voice notes which he can incorporate into his soundscape (sound quality can be cleaned up by Jason and TAPE), facilitated by Placeplan Officer and Members to feed into groups
- Circulation of Mad Afanc story as vehicle for activities with children and young people e.g. groups such as Brownies and Youth Shed doing eg stone painting, dragon scale painting, "faux" pennant creation, (educational) games, with support from local organisations such as Men's Shed who could create the "scales", and She Shed who could create "bunting from recycled materials" for use during a small-scale May 3rd or 4th 2025 "Beach of Dreams Day" at Pensarn promenade.
- Engagement with walkers who might join in to "walk our stretch of coast" (weekend activity with promotional work needed) with the pennant on May 3rd or 4th, or May 10th (bearing in mind the timing will need to allow for walkers to arrive in time to add the pennant to the installation).
- PP Officer to potentially host stand at May 10th to promote our stretch of beach (and Abergele in general), depending on final decisions about this, and participation from other areas which are also part of the network (Llanfairfechan, Penmaenmawr, Llandudno, Conwy).
- Approximate time to implement not including network meetings: seven working days





Welsh Water are rolling out a Smart Meter project in Abergele!

We don't need you to do anything and this won't make any difference to the way you are billed.

Abergele has been chosen as the first location for us to get smarter! Our Welsh Water colleagues will be visiting Abergele over the next few months, installing new meters and replacing older meters with newer technology. We don't need you to do anything and this won't make any difference to the way you are billed.

Once we have the meters installed, we will have occurate, up-to-date data allowing us to quickly identify and fix leaks. In future, you will see more information such as how much water you are using, when you are using it and if you don't currently have a meter, you will be able to compare and see how much you could save by switching over.



Get smart!

Why Abergele?

Why not? Over 75% of our customers in the area are already on a water meter — that's nearly 25% more than the national average! This means that customers in this area already are aware of the benefits of having a meter, can monitor how much they use and understand how day to day activities influence how much water costs.

What can you expect?

Our teams are already out and about, carrying out surveys of all our water connections, so you may have seen us around. The next stage of the process is to install and upgrade meters for all homes and businesses throughout Abergele.

If you already have a water meter, then all we will need to do is swap your old one to a new one. This should only take a few minutes and, as most water meters are outside properties, you probably won't notice us carrying out the work. For customers who have a meter but pay a fixed charge, like our HelpU or Watersure Wales tariffs, this won't change the way in which you pay for your water.

Even if you don't have a water meter now, most of the time we are able to install one without disruption. This is usually outside your property, and this can be done in just a few minutes with nothing for you to do. However, in some cases we will need a little bit more work to put the meter in and we'll do everything we can to keep disruption to an absolute minimum.



Dear Councillors,

Over the next few months, Welsh Water will be carrying out work in Abergele and I wanted to let you know more about this innovative project and what it entails for residents in the town.

Over the next few months, we will be installing over 4,000 new meters with smarter technology on all properties in Abergele – including homes and commercial properties. All current meters will be replaced, and new meters will be installed on currently unmetered properties.

Abergele has been chosen as the first location for us to 'Get smarter' as over 75% of our customers in the area are already on a water meter — that's nearly 25% more than the national average. This means that customers in this area already understand the importance of saving water. It also means that we can easily replace and upgrade a lot of the meters rather than start from scratch.

The first of its kind, the introduction of this smarter network will allow us to keep an eye on water flows, test for leaks, build a picture of where improvements need to be made to the network and look for opportunities to be more efficient. This project will also increase water resilience, offer improved customer service and provides a vital opportunity to learn from our customers.

These smarter meters continuously monitor water flow and pressure which will enable us to detect and react to things like loss of pressure and leakage quicker. This will mean we'll minimise the amount of water we lose unnecessarily and be able to provide greater stability across our network resulting in less disruption to your supply. As well as help us detect leaks on our network, these meters can also help to detect leaks on private systems, which means we can alert customers to leaks on their system so that they can be fixed sooner.

In the future, customers will have much more oversight of their own water consumption although we're not sure yet what form this will take, it will likely be an online portal or app; we don't intend on providing an in-home display for residents.

This is part of a much bigger investment plan we have for the next five years to provide more access to meters and reduce leaks - Abergele will help us lead the way.

Abergele

Our partners IES Utilities (Integral Energy Solutions) are currently carrying out surveys in Abergele of every stop tap and we intend to install the new smart meters from the beginning of October.

For customers that already have a water meter, then we can easily swap the old one for a new one which will only take a few minutes. For customers that don't currently have a meter, in most cases we will be able to install one on the external stop tap which again only takes a few minutes.

Some connections will need a little bit more work to put the meter in and we'll need to dig some holes on the pavement or street, but this work will be planned in to cause minimum disruption and customers will be notified ahead of the work. When we fit the new water meter, we will need to turn off the water for a few moments, but we will let customers know before we do this and work closely with customers that require additional support for such disruption.

Installing the new meters will not affect how our customers are billed, and customers will not need to do anything or be home while we carry out the work. However, if any customers that are currently not billed through a meter would like to move to metered billing we can arrange to have this done.

We should have all the work done by the end of February 2025, but while we are working in Abergele and over the next 12 months we hope to be able to support the town in a number of ways.

Our education team will be visiting local schools to provide free lessons and workshops and our Vulnerable Customer Team will be at Abergele Foodbank every other week from Thursday, September 12th from 10am-2pm along with other agencies to help make sure customers that are struggling to pay their bills are on the right tariff and to discuss how customers can save money on their water bills. We are also keen to support local groups, projects and initiatives through our Community Fund and through our staff volunteering days. If you are aware of any volunteering opportunities in the area that we can be part of, please do let me know.

We will also be supporting Abergele in Bloom through the provision of soil moisture planter monitor and tree moisture monitors to understand whether the soil requires watering and saving water as well as provide the town with water butt installations to maximise water saving potential.

Dros y misoedd nesaf, bydd Dŵr Cymru'n gwneud gwaith yn Abergele ac roeddwn i eisiau rhoi gwybod mwy i chi am y prosiect arloesol hwn a beth mae'n ei olygu i drigolion y dref.

Dros yr ychydig fisoedd nesaf, byddwn yn gosod dros 4,000 o fesuryddion newydd gyda thechnoleg clyfar ar bob eiddo yn Abergele – gan gynnwys cartrefi ac eiddo masnachol. Bydd yr holl fesuryddion presennol yn cael eu newid, a bydd mesuryddion newydd yn cael eu gosod ar eiddo sydd heb fesurydd ar hyn o bryd.

Mae Abergele wedi'i dewis fel y lleoliad cyntaf i fod yn 'Gymuned Glyfrach' gan fod dros 75% o'n cwsmeriaid yn yr ardal eisoes ar fesurydd dŵr – mae hynny bron i 25% yn fwy na'r cyfartaledd cenedlaethol. Mae hyn yn golygu bod cwsmeriaid yn yr ardal hwn eisoes yn deall pwysigrwydd arbed dŵr. Mae hefyd yn golygu y gallwn yn hawdd ailosod ac uwchraddio llawer o'r mesuryddion yn hytrach na dechrau o'r dechrau.

Y cyntaf o'i fath, bydd cyflwyno'r rhwydwaith clyfar hwn yn ein galluogi i gadw llygad ar lif dŵr, profi am ollyngiadau, creu darlun o ble mae angen gwneud gwelliannau i'r rhwydwaith a chwilio am gyfleoedd i fod yn fwy effeithlon. Bydd y prosiect hwn hefyd yn cynyddu gwytnwch dŵr, yn cynnig gwell gwasanaeth i gwsmeriaid ac yn rhoi cyfle hanfodol i ddysgu gan ein cwsmeriaid.

Mae'r mesuryddion callach hyn yn monitro llif a phwysedd dŵr yn barhaus a fydd yn ein galluogi i ganfod ac ymateb i bethau fel colli pwysau a gollyngiadau yn gyflymach. Bydd hyn yn golygu y byddwn yn lleihau faint o ddŵr sy'n gollwn yn ddiangen ac yn gallu darparu mwy o sefydlogrwydd ar draws ein rhwydwaith gan arwain at lai o darfu ar eich cyflenwad. Yn ogystal â'n helpu i ganfod gollyngiadau ar ein rhwydwaith, gall y mesuryddion hyn hefyd helpu i ganfod gollyngiadau ar systemau preifat, sy'n golygu y gallwn rybuddio cwsmeriaid am ollyngiadau ar eu system fel y gellir eu trwsio'n gynt.

Mae ein partneriaid IES Utilities (Integral Energy Solutions) ar hyn o bryd yn cynnal arolwg yn Abergele o bob stop tap ac rydym yn bwriadu gosod y mesuryddion clyfar newydd o ddechrau mis Hydref.

Ar gyfer cwsmeriaid nad oes ganddynt fesurydd ar hyn o bryd, yn y rhan fwyaf o achosion byddwn yn gallu gosod un ar y *stoptap* allanol, sydd eto ond yn cymryd ychydig funudau.

Bydd angen ychydig mwy o waith ar rai cysylltiadau i osod y mesurydd a bydd angen i ni dyllu rhai tyllau ar y palmant neu'r stryd, ond bydd y gwaith hwn yn cael ei gynllunio i achosi cyn lleied o aflonyddwch â phosibl a bydd cwsmeriaid yn cael eu hysbysu cyn y gwaith. Pan fyddwn yn gosod y mesurydd dŵr newydd, bydd angen i ni ddiffodd y dŵr am ychydig eiliadau, ond byddwn yn rhoi gwybod i gwsmeriaid cyn i ni wneud hyn ac yn gweithio'n agos gyda chwsmeriaid sydd angen cymorth ychwanegol ar gyfer aflonyddwch o'r fath.

Ni fydd gosod y mesuryddion newydd yn effeithio ar sut mae ein cwsmeriaid yn cael eu bilio, ac ni fydd angen i gwsmeriaid wneud dim na bod adref tra byddwn yn gwneud y gwaith. Fodd bynnag, os hoffai unrhyw gwsmeriaid nad ydynt yn cael eu bilio drwy fesurydd ar hyn o bryd symud i filiau â mesurydd, gallwn drefnu i hyn gael ei wneud.

Dylem gael yr holl waith wedi'i wneud erbyn diwedd Chwefror 2025, ond tra ein bod yn gweithio yn Abergele a thros y 12 mis nesaf rydym yn gobeithio gallu cefnogi'r dref mewn nifer o ffyrdd.

Bydd ein tîm addysg yn ymweld ag ysgolion lleol i ddarparu gwersi a gweithdai am ddim a bydd ein Tîm Cwsmeriaid Bregus ym Manc Bwyd Abergele bob yn ail wythnos o ddydd Iau, Medi 12^{fed} ymlaen (ac eithrio Medi 26ain) o 10am-2pm ynghyd ag asiantaethau eraill i helpu i wneud yn siŵr bod cwsmeriaid sy'n cael trafferth talu ar y tariff cywir ac i drafod sut y gall cwsmeriaid arbed arian ar eu biliau dŵr. Stakeholders and Delivery Plans

Dwr Cymru has been in touch with Darren Millar, MS and Charlie McCoubrey, Leader, thus far, with a view to opening a dialogue

It was suggested that Dwr Cymru should also be in touch with Gill German, MP Action: Placeplan officer to share Gill German's contact details

Dwr Cymru had also met with CCBC Highways. They presented historical data as benchmark for anticipated dig requirements, and were asked to complete the surveys and come back with current local data.

Therefore, the team had been expanded with eight team members conducting surveys, and two more completing induction.

Thus far, survey data mirrored projected data, which was positive from a planned delivery perspective, and the deadline for this work was set for w/c September 23rd

The dig start date could not yet be determined, as this would depend on the completion of the survey, data submission, and the subsequent notice period required by CCBC Highways, which could be 12 weeks if the work was classed as "major".

Sensors

Clerk and Placeplan Officer had had contact from CCBC regarding the donations of water sensors, and potential ways of managing this as a donation, and sought context clarification, as this was different to what had been shared during Dwr Cymru's presentation at the Placeplan meeting in July, where they had opened up an offer of water butts to interested groups.

Dwr Cymru explained that WG had suggested, as part of the SMART Towns agenda, that Dwr Cymru donate a number of water sensors, which could be distributed and used to improve watering efficiencies.

Anticipated value of the donations was £5k overall, with each sensor costing approximately £150 ea.

From Dwr Cymru's perspective, they were happy to do this, provided that the data was captured and presented back to the public.
