Good afternoon

Thank you for your e-mails regarding the campervan situation on Pensarn Promenade which were received at the General Purpose and Planning Committee 14th October 2021.

It was acknowledged that there are problems associated with the influx of staycationers especially in North Wales, but Members felt that it should also be seen as an important boost to tourism which should be welcomed. It was also recognised that the behaviour of a minority of them was a strain on services and an irritant to local communities and fee-paying campsite visitors.

In order to manage the situation positively it was felt that actions could be taken in collaboration with CCBC to accommodate the extra visitors appropriately i.e create spaces close to amenities for transient holidaymakers, to minimise the impact that

multiple motorhomes have on the local community when stopping overnight on residential streets, parks access routes, lay-bys and the Prom etc. It is understood that CCBC are investigating the possibility of a Bye Law preventing camping on the highways immediately in the vicinity of Pensarn Prom and this had the support of Members.

Going forward the general consensus was to support the County in striking a balance between providing a welcome whilst at the same time limiting opportunities to those who seek to take advantage by overstaying that welcome.

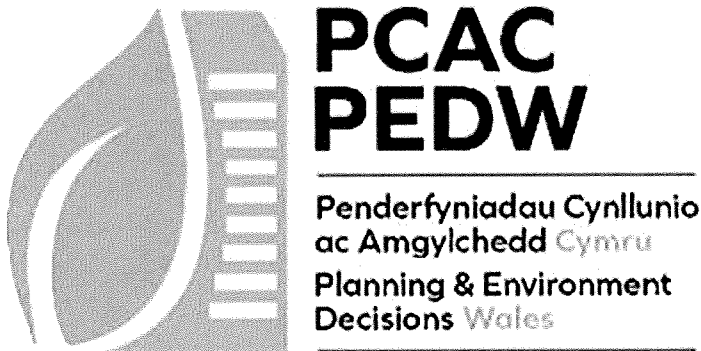

## Meeting Notes

A meeting of the Task and Finish group was held at 6:45 pm on Monday 25th October 2021 by remote attendance.

1. **Attendance Register**

2. **Apologies for Absence**

Cllrs: Dr. M. Baker; G. Frost; S Rowlands;

3. Ms Melanie Gizzi from Abergele Dementia Friends was welcomed to the meeting to provide a Dementia Information Session for the Members

4. Dementia Friends is an Alzheimer's Society led initiative which aims to increase dementia awareness and change the way the nation thinks, talks and acts about dementia.

5. There are 5 key messages to understand and a commitment needed to dementia friendly actions to help develop dementia friendly communities.

- a. It is not just about ageing. There are many people who age without developing dementia
- b. It is a disease of the brain as with any other organ of the body (over 100 different types of dementia)
- c. It is a change of perception of the world around you which could affect any area of life such as motor skills, sequencing, visual perception, changes in inhibition communications etc.
- d. It is possible to live well with dementia with the right support. Listening, reducing distractions, speaking slowly and clearly, body language and respect
- e. There is more to a person than just dementia. Memories of emotion are stronger than memories of the factual

Melanie stressed the importance of keeping in touch with people living with dementia. Use the Alzheimer's Society website as a source of information and guidance

6. The Bookcase analogy was demonstrated.

7. Melanie explained the different ways in which it is possible to engage with the development of a dementia friendly community from volunteering to display the digital Dementia Friend badge on social media posts and pledging actions to make small changes in your environment that would matter a lot to someone living with dementia.

8. Members discussed the information received and agreed to RECOMMEND to Full Council the following points
  - a. A promise to raise the dementia friendly profile via Social Media
  - b. To consider a dementia friendly policy at the Council in the event one of its Members is diagnosed with dementia.
  - c. To organise refresher training for new and existing councillors at timely intervals or after elections
  - d. When planning an event, to consider making small dementia friendly changes to improve the experience of attendees living with dementia.
  - e. To consider a periodical audit of dementia friendly actions taken
9. It was NOTED that Cllr Williams had been running dementia friendly information sessions with children and staff at his business premises prior to lockdown and wished to restart them. It was also NOTED that the Placeplan Facilitator was also keen to become involved in developing new and recent projects with a dementia friendly action perspective. Jesse's contact details to be forwarded to Melanie.
10. Melanie ended the session with information on how to find out more about support, connections, becoming a Dementia Champion and Alzheimer's UK.

Members thanked Melanie for her time.
