I refer to the above and wish to inform you that a Contractor has been appointed to undertake work to upgrade a Road Restraint System on the verge of the main A55 carriageway at Junction 24 Faenol Interchange, Abergele eastbound.

This could result in a higher than usual level of noise at intervals and I take this opportunity in apologising in advance for any inconvenience incurred.

The proposed start date for the project is 12th February 2024 with the duration expected to be up to 26 nights.

I haven't had direct experience of Bardic Stones signage, but there are some general principles which apply to all signage.

Plain language – less is more! Aim for an average sentence length of 20 words, and use bullet points where you can. Word allows you to check reading ease – aim for a score above 50 (and preferably above 60)

Headings – use headings to break up text and let the reader jump to what they're interested in. These can be in the form of questions (What is special about these stones?) or enticing (Special stones mark the spot)

Contrast – make sure there is sufficient contrast between text and background, and choose colours which do not fade easily (although this website is focused on digital contrast, it's useful for checking print materials too: <https://webaim.org/resources/contrastchecker/>)

Text size – signs need a bigger text size as people stand further away to read them (compared with a book or letter). Recommend a minimum of 16, but 20 for preference and much bigger for headlines to grab attention from a distance.

Language choice – the Council make all signs bilingual. This can either be made clear through placement (e.g. Welsh on the left, English on the right) or by colour (e.g. Welsh in black, English in blue). Even better, use placement and colour to make it easy for someone to read their preferred language. Where possible, label images in both languages, to avoid taking up space with duplicated images.

Space – leave plenty of space on the sign around text and images. This allows people to read easily. It's a common mistake to cram so much information onto a sign that it looks off-putting.

I hope this helps. Happy to offer any other assistance I can.

Dear Mr Grimward

We are working on getting a communication out to all Town and Community Councils to let them know the outcome on proposed services cuts, however as you have specifically asked the question about the community skip service I can let you know about that now.

With severe budget pressure, each service has had to put forward service cuts so that savings can be made. One of the service cuts the waste department put forward was ceasing the community skip service. This was not something we wanted to do but after years of budget cuts there were very few viable alternative options to put forward. The service cuts put forward were debated by Council and in the case of the community skip service it was approved that to meet the savings the service should cease effective from April 2024. Whilst the Council will no longer provide a community skip service, services are still available to town & community councils through commercial skip providers albeit they will not be at the subsidised price that was offered under the Council's service. To put that in to context, the cost of Council provided community skip was ~£260 per skip whereas an equivalent skip from a commercial skip provider would charge in the region of £700. I understand this will be disappointing news but this is sadly where we are.

Survey of Pedestrian Signage in Conwy County

We are undertaking an audit of Fingerpost Signage in Conwy County. The project is funded by the Welsh Government Brilliant Basics Fund and includes four towns, namely: Abergele, Colwyn Bay, Llandudno and Llanrwst.

The following survey forms part of the audit of fingerpost signage in the County. It will map out existing signage and will also help provide

recommendations for works including the installing of new fingerposts and/or the renovation and/or removal of existing signage. More information can be found in the attached **Briefing document**.

We recently held a workshop at which we received some invaluable feedback from businesses and organisations from within our communities, which will help shape the final report and the recommendations going forward. Our aim now is to expand on that knowledge and capture similar information from the wider community.

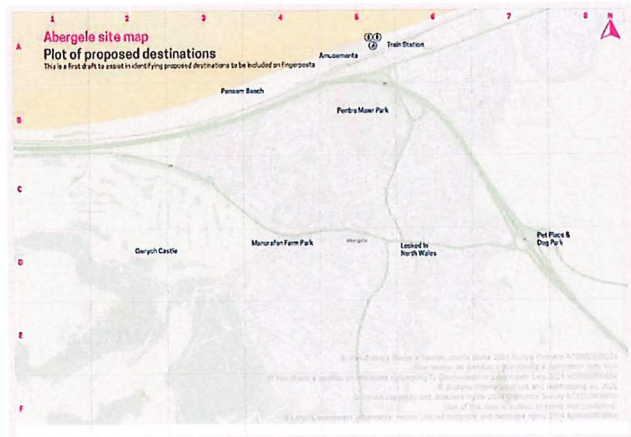

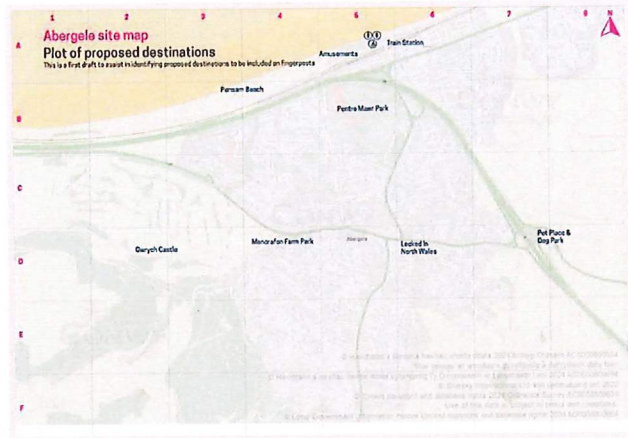
