Dear Members of Abergele Town Council,

I hope that members of the council don't mind me contacting in this way and for choosing to make representations regarding the Welsh Language, culture and heritage in the town of Abergele.

I am a long standing inhabitant of Abergele, where I ran a business for some years, I am a member of the Mynydd Seion Chapel and a former Chair of Governors at Ysgol Glan Morfa. I am currently Head of the Wrexham University.

I also hope that you don't mind me making these representations in the English language rather than the Welsh Language.

There may be some members of the council who cast an eye occasionally on the 'Abergele Noticeboard' on Facebook. I have to admit that until recently I had never done so, and in my naivety posted my opinions and concerns about the recent change of name of the 'Pen y Bont' public house. The views I expressed were of concern about the lack of respect given to the language, culture and heritage of our town.

I don't wish to revisit the comments about the whole debacle which ensued following my innocent and polite comments in any great detail, but, I believe it's only fair to say that the event did cause me some concerns.

One individual stated 'We live in 'Livershire', Abergele is not part of Wales' and another said 'I didn't move to Abergele because of its language and culture I moved here because the houses were half price' There were many other comments about the Welsh language, culture and heritage of our town which at best were insulting and at worst abusive and very unpleasant.

I realise that these comments must be taken with a 'large' pinch of salt and that they, I hope, are the views of a small, albeit a noisy, proportion of the population of our town. It did get me thinking though, about the whole question of the Welsh language, culture and heritage of Abergele and the attempts that could, and some would argue should, be made to ensure that all three of these elements be more visible and relevant to the life of our town.

Abergele is after all the birthplace of Emrys ap Iwan one of the stalwarts of the Welsh language and identity at a time when both were being challenged with the threat of extinction by the English establishment and of Winifred, Countess of Dundonald, otherwise known by her bardic name 'Rhiannon' who was a mainstay of the National Eisteddfod and a great supporter of Harp music, some would argue that it was her work which ensured that the harp is the national instrument and one of the symbols of Wales.


Some may think that the language and cultural identity in Abergele is not worth preserving, some, like the keyboard warriors on Abergele Noticeboard may believe that we are just like any other town, void of identity, uncaring about our history, language and identity, just a banal town, lacking in personality. I strongly disagree.

I wish to take the opportunity of addressing the members of the council on what could be done, indeed, what should be done to retrieve the identity of our town. I believe that Abergele's language and history is important, I believe that our heritage had a crucial part to play in Welsh history, allowing this to disappear into a characterless conurbation that some call 'Livershire' is a mistake.

I would appreciate the opportunity of addressing you on the opportunities, possibilities and challenges of making Abergele a more cohesive, tolerant and understanding place to live, where we all have an opportunity to express ourselves in the language of our choice and to have pride in our history and heritage without criticism or abuse.

I hope this email is taken in the spirit it is intended and that you allow me the opportunity to address you further at on of your council meetings..

We are contacting you in your capacity as a statutory consultee to confirm that our application for development consent has been accepted for examination by the Secretary of State for Energy Security and Net Zero.

This means that our application has satisfied the formal acceptance requirements set by the Planning Inspectorate and can move forward to the examination stage of the consenting process.

Pursuant to Section 56 of the Planning Act 2008 and Regulation 16 of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017, please find enclosed a formal notice of acceptance. NOTICE OF ACCEPTANCE OF AN APPLICATION FOR A DEVELOPMENT CONSENT ORDER ("DCO")

Notice is hereby given that the Secretary of State for Energy Security and Net Zero has accepted an application by Mona Offshore Wind Ltd (the "Applicant") of Building B, Chertsey Road, Sunbury on Thames, UK, TW16 7BP for a Development Consent Order ("DCO") under the Planning Act 2008 ("the Application"). The Application was submitted by the Applicant to the Secretary of State, C/O the Planning Inspectorate on 22/02/2024 and was accepted on 21/03/2024. The reference number applied to the Application by the Planning Inspectorate is EN010137.

The Application is for development consent to construct, operate and decommission the proposed Mona Offshore Wind Farm (the Project) located off the coast of North Wales. The Project comprises up to 96 wind turbine generators and associated onshore and offshore infrastructure. The Project will be located within Welsh waters and within the Counties of Denbighshire and Conwy.

The DCO application will cover:

- construction, operation and maintenance and decommissioning of the Project;
- the compulsory acquisition of land including rights in or over land required for the purposes of the Project, and land required to facilitate or is incidental to the Project;
- the application and/or disapplication of legislation relevant to the Project including that relating to the compulsory acquisition of land; and
- further provisions, permissions or consents as are necessary and/or convenient including a deemed marine licence.

The Project

The Project consists of a proposed offshore wind farm located in the Irish Sea, and associated offshore and onshore infrastructure. The wind farm is expected to comprise up to 96 wind turbine generators. At the closest points the array area is 28.8 km from the north coast of Wales, 46.9 km from the northwest coast of England, and 46.6 km from the Isle of Man. The offshore export cable corridor will be approximately 46 km in length and the onshore export cable corridor (including 400 kV cable corridor) will be approximately 16 km in length.

The proposed DCO will, among other things, authorise:

- a) The construction and operation of up to 96 offshore wind turbine generators and their foundations:
- b) The construction of up to four offshore substation platforms (OSP) and their foundations;
- c) The construction of a network of subsea inter-array cables connecting the wind turbine generators and a network of interconnector cables connecting the OSPs;



- d) The installation of up to four subsea export cable circuits to transmit the electricity generated by the wind turbine generators to shore. The Project's offshore export cable corridor extents south-eastwards from the array area to the proposed landfall at Llanddulas in Conwy;
- e) The construction of up to four transition joint bays at landfall connecting the offshore cables to the onshore cables;
- f) The installation of up to four underground onshore export cable circuits connecting from the transition joint bays at landfall to the project onshore substation;
- g) The construction and operation of a new project onshore substation to the south of St Asaph Business Park and Glascoed Road in Denbighshire;
- h) The installation of up to two underground onshore export cable circuits connecting the proposed onshore substation to the National Grid Bodelwyddan substation to allow the power to be transferred to the National Grid; and
- i) Works to connect the Project to the National Grid Bodelwyddan substation in Denbighshire.

The DCO would also authorise the compulsory acquisition of land, interests in land and rights over land, and the powers to use land permanently and temporarily for the construction, operation, maintenance and decommissioning of an offshore wind farm.

Environmental Impact Assessment - The Project is an Environmental Impact Assessment (EIA) development as defined in the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017. Consequently, the Applicant has submitted an Environmental Statement as part of the Application. A Non-Technical Summary ("NTS") of the Environmental Statement is also available.
