To The Abergele Town Clerk

Please find attached a series of email exchanges I have had, as Secretary of Abergele Bowling Club, with Mr [REDACTED] regarding parking issues on Peel Street and Pentre Ucha.

Whilst, as you can see, I have explained to Mr [REDACTED] that it is very difficult for the Bowling Club to attempt to enforce parking restrictions that largely do not exist, I do have considerable sympathy for his position.

These issues have largely been brought about by the changes to the Water Street Car Park to free parking with no restrictions whatsoever. Whilst the reasons behind doing this were no doubt worthy aiming to encourage visitors and shoppers to use Abergele, the effect appears to have been the exact opposite with the Car Park being full by 9am and largely remaining so throughout the day. Whilst I have no empirical evidence to back this up, it is difficult not to draw the conclusion that the Car Park is being used by local businesses and their employees together with car sharers leaving their cars all day. The fact that the problems do not exist on a Sunday seems to support this conclusion.

Whatever the reason, the Car Park has now become effectively redundant for most of the day Monday through Saturday and is not able to be used by transitory parkers such as Shoppers and our Members wishing to pay Bowls. This, together with the understandable addition of double yellow lines outside the Bowling Club on Water Street, inevitably leads to the problems described by Mr [REDACTED]

Can I please ask that this issue is raised at the next Council Meeting and consideration given to either the reimposition of charges or a time limit for the Water Street Car Park.

I have copied in the Gele Ward Councillors and the Mayor together with Mr [REDACTED] so that they are aware of this request.
