The Clerk informed members that an email had been received from CCBC that evening stating that they did not have the information at present. It was AGREED to DEFER for one month to set a budget.



327/23 Gohebiaeth – Correspondence

The following correspondence was RECEIVED, CONSIDERED and NOTED:

 a) Cllr. Shirley Jones-Roberts provided members with an update from the North Wales Association following the meeting held on the 20th October 2023. Cllr Jones-Roberts informed members that the association held a minute silence for past Councillor Richard Waters.

The first meeting of Youth representative had taken place, and unfortunately, no youth representatives from the North or Mid-Wales area attended; clarification will be required on whether Abergele would like a representative. Many towns have taken up the offer from Smart Towns for free WiFi, would

recommend that the item is considered as part of the Placeplan when an Officer is in post.

The Councillor Allowance for consumables is no longer taxable.

Cllr Wood informed members that the rail user group for North Wales discussed the new smaller trains carrying less public with only one toilet per carriage. Findings from a survey has been referred to the HSE. Not for long distance and not accessible for disabled users.

- c) An email from One Voice Wales with regard to RAAC was RECEIVED. It was NOTED that the Clerk had responded to a recent request from Welsh Government with information received from North Wales Police.
