0/51041	access from St George Road, associated public	Land North and South of St George Road Abergele Conwy	 Abergele Town Council object to the application for the following considerations: The Active Travel Plan is not sufficient or fit for purpose and additional provision should be provided. On the boarder of the development there is a Public Right of Way, it is not clear if this will be part of the cycle path and if pedestrians and cyclists will have to manoeuvre around each other. It is stated that 60% of the traffic will turn right – this development will create a bottle neck into Abergele. St George Road is too narrow for the volume of traffic. The original Atkins report stated that the town was at saturation point. The current infrastructure is not adequate alternative solutions should be considered prior to planning permission being granted.
