b) Green Gele - Events space

An item deferred from the last Place Plan Committee meeting (PM: 371/22) with regard to the Green Gele project was brought to the meeting. Guests, Shane Wetton, James Harland (from CCBC) and Liam Gaskell (from TEP) were invited to present the amended project proposals as requested by the Council at the previous meeting.

The Chairman reminded the guests that the presentation must not disclose any confidential and commercially sensitive information as members of the public were in the room.

A presentation regarding the Green Gele Proposals was made by Liam Gaskell.

In regards to the event space in Pentre Mawr Park, two options were presented: a contemporary design (as provided at the last meeting) and a more traditional design (bandstand) as an alternative option.

In regards to the green infrastructure proposals, designs for Pentre Mawr and Parc Gele were provided at the last meeting and for this meeting a detailed planting schedule was included.

Members had requested for footpaths to be considered and two options for Parc Gele were presented at the meeting.

A new proposal for a natural play scheme was also presented at the meeting.

The question was raised as to whether an event space was required and could the project not be a fully greening one instead.

CCBC emphasized that a community hub was required as part of the grant conditions. CCBC clarified that community hub could take the form of a community building or an event space.

CCBC explained that the project must score accurately to the original project in the bid for the grant. The deadline for changes was 31st January 2023 so it is unlikely that Welsh Government would consider any further changes. CCBC stated that if Abergele Town Council went ahead without a hub, potentially they

would lose the funding and that there would be no project at all.

CCBC understood that originally the project had been based on a sports hub but due to circumstances the Sports Association had withdrawn from the project and

alternative options were presented to the Town Council. CCBC explained a

greening project would be a complete change of scope.

CCBC highlighted that the planting element of the project was time critical and that they had contractors waiting. CCBC stated there was an eight week deadline for this element.

It was unanimously RESOLVED that a Linda Taverner is a lay member of the Place Plan Committee (as this was a deferred item from the Place Plan meeting) could remain in committee as a non-voting member.

Correspondence from a member of the public regarding the installation of a dog waste bin off Llanfair Road, near the entrance of Celyn Vets was RECEIVED.

Officers provided clarification: CCBC treat litter bins and dog waste bins differently. Litter bins have to be dealt with as whole scheme and currently there is no funding to add new or repair damaged. CCBC may have the capacity to install a dog waste bin and empty them. CCBC do not have the funding to replace damaged dog waste bins or install new. CCBC estimate costs to be between £200 and £300 to install a new dog waste bin.

It was unanimously RESOLVED that the Town Council fund the installation of a new dog waste bin on Llanfair Road near Celyn Vets. It was FURTHER RESOLVED that £300 should be committed from the Street Furniture budget 2023/24.
