#### 190/24 <u>Website presentation by Delwedd</u>

Cllr Williams welcomed Aled from Delwedd to the meeting, Aled gave a brief background to Delwedd Web design company, including information about their core business. Aled advised that their main business is in North Wales consisting of Schools and Town Councils, and they currently have close to 450 live websites. Delwedd have featured as finalists in the Welsh Business Category and they are passionate about promoting the Welsh language which is automatically built into their websites at no extra cost.

Aled went through the new website design, members agreed they liked the new format, which was 'clean, crisp and clear', Aled confirmed that as a host Delwedd



ensure, that they follow all the Legal requirements, and regular on-going maintenance.

Aled confirmed that content submitted from ATC Officers before 12 noon would be made live that same day, social media feeds could be added to the website to show recent posts, and added that Delwedd had access to Adobe stock images that could be used. Aled also explained that ATC would receive a regular tracking report including popular pages/searches.
