Cllr D. Green PROPOSED that Cllr. T. Jones is elected as Deputy Mayor for 2024/25, SECONDED by Cllr. K. Yarwood

Both Councillors indicated that if nominated that they would be willing to accept the role.

Members voted which resulted in a unanimous vote for Cllr. Brennan.

Cllr. Brennan, was elected at Deputy Mayor for 2024/25.

510/23 Y diweddaraf gan Gynghorwyr Sir – Update from County Councillors

- Derbyn adroddiadau llafar gan Gynghorwyr Sir / verbal reports from County Councillors was RECEIVED:
 - a) The Leader and Cabinet have been working hard on the budget. There is likely to be a £18m shortfall in the budget for 2025/26. A reduction in Library hours, and a cut in funding for CAB are among the cuts for 2024/25
 - b) Welsh Government had provided £25m to Councils to reinstate social care which has increased by £2.26m
 - c) 72% of the budget is revenue funded, teachers' pension has increased by £8m £14.4m for other staff. Of the £22m for pay Welsh Government have only funded £4.6m. The fees for Telecare has been rejected, nappy collection will remain as is. 2000 Statutory duties to comply with. Savings on energy costs of £1.6m have been made. All is unsustainable at present which will result in a cut in service and a rise in Council tax.
 - d) Shared Prosperity fund allocation received
 - e) Under 18, 6 Nations ladies Rugby is coming to Colwyn Bay for four days from the 1/4/24
 - f) Police & Crime Commissioner have agreed to increase the precept adding 0.32p per week, details are on their website.
