76/23 Guest Speaker

The Chairman welcomed Prof. Nathan Abrams from Bangor University, who provided members with an overview of a Jewish Heritage Trail project for the Abergele area. Prof. Abrams informed members that in 2006 he studied the history of North Wales, and provided walks and talks in Bangor, Llandudno and Colwyn bay, and is now seeking assistance for the Abergele area. Prof. Abrams informed members that he had followed the history of the Community back to when Edward I expelling the Jewish community from Wales in the 13th Century. This will be a walking Jewish History guided tour and also local people's history, carrying out research and make accessible to all. The aim is to create a voice map as well as normal maps, turning into exhibitions, an app and facilitate bilingual walks, similar to 'A Jewish history of Anglesey' that has already been created.

There are no synagogue records. Members were keen to be involved in the project and Prof Abrams will keep in contact with Clerk with regard to fundraising from local sources for help with walks and exhibition panels.



The Mayor thanked Professor Abrams for his engaging overview of the project.

80/23 Matters arising on those and previous Minutes

a) An update from the Clerk with regard to the Pentre Mawr Election was RECEIVED and CONSIDERED. The Clerk advised that the Council had received numerous complaints with regard to the decision to not issue Polling cards for the last election, that the public did not know who the candidates where, and not aware that the election was taking place.

It was NOTED that to host an election the cost to the Town Council is over £3.5k without the cost of poll cards. CCBC have made an offer to engage their staff as volunteers which at a cost of £602.70. Living in a high retirement area who do not use social media is also a factor. Clarification on who CCBC use as a courier was requested and the Clerk confirmed that the volunteers were CCBC staff who also volunteer for other roles, a core group of people. Candidates should also spread the word in the Community.

It was PROPOSED by Cllr. A. Hunter that the new offer of using volunteers at a much lower cost should be accepted and Poll cards should be issued. It would be interesting to note if there is a higher turnout, as a gage for the future.

The Clerk explained that next year he would then not be a member of the Committee if there were no vacancies arsing. This was AGREED by Cllr. McCoubrey.

87/23 Y diweddaraf gan Gynghorwyr Sir - Update from County Councillors

- Derbyn adroddiadau llafar gan Gynghorwyr Sir / Verbal reports from County Councillors were RECEIVED as follows:
 - a) Domination by budget group meetings for next year due to significant shortfall.
 - b) Police and Crime Commissioner AGM is on the 26th June, Councillor will report back.
 - c) Mona Wind Farm proposed off shore wind farm infrastructure; the use of Sea Road Bridge and Pensarn station have been discussed, concerns on how they propose moving heavy goods on a weak bridge, and any damage to the SSSI area. County Members are consultees. Members will request clarification on how this is to be considered.



- d) Challenging time with the 9.9% increase in Council tax and £11m service cuts, school transport, loss of £70m over last 9 years, challenging when viewing the detail.
- e) A Peer Review has been carried out by Welsh Government to view the democratic process over delivery which is a difficult balance to find. A Report and Action Plan will be produced to 2030-35 to deliver longer term planning
- f) North Wales growth deal £860m, 7 new projects going forward. The projects are worth £30m to the County. These are exciting projects and deliverable. Would be transformational for Conwy.
