#### 440/24 Visitor to the Council

The Deputy Mayor welcomed representatives from the Hygiene Bank to the meeting who provided members with an overview of their recent grant application. They confirmed that



although the organisation was nationwide the group is local and provide services the local community. All funding initially goes to the main charity but is then ring fenced and drawn down to the local area when required. The group have only been running for 6 months and are still looking for partnerships and asked ATC for recommendations, which were suggested. That partner would then decide who to allocate the packs to.

The Chairman thanked the representatives for attending the meeting and they retired from the meeting.

#### 449/24 Y diweddaraf gan Gynghorwyr Sir – Update from County Councillors

- Derbyn adroddiadau llafar gan Gynghorwyr Sir / Verbal reports from County Councillors were RECEIVED as follows:
  - a) There has been a water outage at Dolgarrog where a pipe has ruptured last night. The best case for repair is tomorrow and then it will take 48 hours for the water to be reinstated to all households and businesses. Welsh Water have a duty to supply 10l of water to all those effected but the stock is depleted after the recent floods. 5000 people are deemed at risk and are a priority. Schools and offices are closed due to not being lawful to open without facilities for staff.



Hopefully the shops will be restocked with water overnight. There will be two water stations opening tomorrow. Emergency accommodation is a problem as they should close but this would put vulnerable people on the streets therefore CCBC are seeking an exemption from Welsh Government. It will be a difficult weekend.

- b) There is an assumption that the budget will raise by 10.26%. The budget working group has been drilling down on the schools budget. Audit Wales have indicated that CCBC have been operating on short term business basis and need to take transformational decisions.
- c) There was a positive meeting with regard to the pump track
- d) There is a meeting for the 3G pitch tomorrow
- e) There has been progress on the Pensarn flats.
- f) The windows at Bowden House will be replaced
- g) No progress on the planning application for the old Bee Hotel.
- h) Abergele Conservation Trust has been awarded the lease on the old School building.
