The Mayor welcomed Melanie Lawton, Community Rail Manager (North) and James Timber, Social & Commercial Development Manager, from Transport for Wales to the meeting who provided members with a presentation on the work to date at Abergele Pensarn Train Station.

Melanie explained to members that her role is to transform train stations into hubs, which are fully integrated into the community, and bring disused spaces back into use. This involves linking with the community to see what can be achieved. The current project involves refurbishing Pensarn Station as a commercial opportunity and Platform 1 and 2 for social/community use.

Expressions of interest have been received for the main building but stress that they are not seeking this building to compete with any existing business in the town. A Visioning event will planned in order to present ideas such as a foodbank or social enterprise for Platform 2. Expressions of interest have been received from Conwy Youth, Housing and Youth Homeless or as a drop in centre for Health & Wellbeing. They are seeking to regenerate the community and have a social

impact, with options for project work and will invite interested parties to come to site.

As a listed building, the project has Heritage funding and an offer has been extended to a creative enterprise. A video of the work will be created and they will forward to the Clerk for members and the website information. There is also an option for Artwork to be displayed.

The lease is currently 6 years, the rent is flexible and under review based on the percentage turnover of the business. Occupancy is at the forefront.

The Mayor thanked Melanie and James for their attendance.
