Matters arising on those Minutes

(i) The recommendations made by the Estimates Committee in preparing the Draft Annual Estimates for 2025/26 were RECEIVED and CONSIDERED, together with amendments that were approved at the last Ordinary Meeting of the Council. The matter of inclusion with the precept for an

additional £5636 to the provision of the Pensarn toilets was debated and the Clerk amended the figures on screen to provide members with an overview of the implications of increasing the precept over increasing the use of reserves. It was RECOMMENDED to APPROVE the revised figures with the increase to the precept.

- (ii) A copy of the proposed Fees and Charges for 2025 were RECEIVED and CONSIDERED with the six-month trial for a special offer of reduced rates on the main Chamber was APPROVED
- (iii) The Annual Estimates for 2025/26 and agree the level of the precept, for submission to CCBC were RECEIVED.

It was PROPOSED, SECONDED and APPROVED that an increase in the Band D from £68.29 in 2024/25 to £70.70 for 2025/26. It was AGREED that the 2025/26 Precept is set at £366,459, an increase of £18,173 from the 2024/25 Precept of £348,286.
