a) An update from the Clerk with regard to the Abergele Playing out 2023 suggestions for alternative activities was RECEIVED. The Clerk informed members that the budget is £1900.

630/22 Other Matters

- a) The Clerk informed members that the Council had received a gift of a framed old Abergele photos which was presented to Gwyn Jones (Past Clerk) on his retirement from a local resident.
 - It was RECOMMENDED to send a letter of thanks to the resident.
- b) An update from the Clerk and Mayor on the takeover of the Abergele toilets was RECEIVED. This included the Header terms, legal costs, Pensarn drainage issues, meters, the cost of cleaning and an update on the Pentre Mawr toilets and CCTV provision. Estimated costs for the takeover were RECEIVED. It was suggested that future Precept costs could be around £20 per household. The Town Council would not like to perceive the closure of the toilets and wish to explore all the options as they may not be able to sustain the current envisaged costs.
 - It was RECOMMENDED that the Town Council do not agree to the take over the toilets until all outstanding matters are rectified and the CCTV is installed. The Council has concerns with regard to the drainage at Pensarn, would also like the meters separated before takeover and the swipe and go device problem rectified.
 - It was RESOLVED to write to the Chief Executive of CCBC to invite him to attend a meeting with the Council to discuss the matter, including other possible options i.e. sponsorship
- c) The questions for any future Council co-option was RECEIVED and it was RECOMMENDED that if a member has any observations with regard to the questions to forward to the Clerk. The item was DEFERRED to the next meeting for review. Public engagement was discussed and how to encourage candidates to come forward, including the negative social media experiences that may deter potential candidates.
- d) Cllr. Pauline Heap-Williams AGREED to be an emergency key holder for the Town
- e) It was NOTED that this year the Town Council will be subject to a full Audit for 2022/23
