Good afternoon all.

Just a quick update following our grants panel meeting yesterday.

Panel were happy for us to explore further, the potential of developing a pilot project around green energy/green buildings / carbon footprint/ the environment etc. in partnership with A/gele Town Council and the Place Plan.

They added one word of caution. Given our annual budget across the three counties is only circa £680,000 a project of this magnitude could easily swallow a large percentage of available funding. Therefore they requested we proceed cautiously without falsely raising community expectations.

This project could be developed over 2 years and lessons learnt used to create a model for other communities.

How would you propose we proceed from here folks?

To remind you these were the stages we felt would facilitate such a proposal

- Stage 1: Identify and list community owned or managed buildings in the town eg ITICA, Abergele Rugby Club, Gwrych Castle etc
- Stage 2 : Contact management committees of each and invite them to attend a green energy / energy saving education and awareness session(s)
- Following the session(s) identify any groups interested in progressing energy ideas to -
- Stage 3: Undertake an energy survey and report on each building to ascertain requirements (perhaps include best locations to install electric car charging points)
- Prioritise buildings together with costs to undertake improvements
- Stage 4 : Submit proposals to GYM for consideration



Re: Abergele Bandstand

I am writing on behalf of Beulah Brass Band, the resident brass band in Abergele, to request that the Town Council examine the necessity for a permanent bandstand in Abergele. During the Christmas period, and prior to the recent lockdown, Beulah Brass entertained the residents of Abergele by a series of "pop-up" sessions to play Christmas carols. We understand that, whilst we were warmly appreciated by onlookers, there was also more general appreciation of the presence of a brass band in Abergele.

We respectfully request that consideration be given to the siting of a permanent bandstand. Whilst the band would commit to regular concerts during the summer it would also be available to local choirs, schools, and other groups for their performances. If the bandstand were sited in Pentre Mawr Park, we believe it would attract a regular and substantive audience and raise the profile of Abergele Town in general.

We understand that several groups in Abergele are in favour of such a development – Abergele Rotary Club, Abergele Dementia Friendly Group – and I suspect that, should this have the backing of the Town Council, many more groups would give their support to this venture. I would be quite happy to be personally involved in such a development,





Hi,

Thanks for your enquiry about Pensarn beach.

As you can imagine this kind of enquiry has been raised previously and we are currently exploring a potential project that could see the improvement of the promenade at Pensarn which could include beach access. Wheeled access to a beach can prove extremely challenging and the safety of users must be paramount to ensure no-one is at risk when tides rush in. As I'm sure you will appreciate, a project of this size requires a lot of planning and we are currently only at very early stages but alongside some of the Place Plan work in the town we are also keen to see some developments in Pensarn and have worked very closely with Transport for Wales on the project to bring the station buildings back in to use.

The Abergele Place plan is administered and managed by a local partnership, Abergele Place Plan Board, the board is a Town Council Committee and further information is available on their website Abergele Town Council (abergelepensarn.co.uk). The Town Council are also currently looking to appoint a Place Plan Facilitator who will be a local contact for any Place Plan enquiries. I have copied the Town Council and 2 Local Councillors in to my reply, Cllr Alan Hunter, who is also the current Chair of the Place Plan Committee, and Councillor McCoubrey both I know are very keen to see the project progress and have been part of the initial discussions

Further to your email and response from Shane Wetton regarding beach access.

This is something that I have kept on the table at every discussion regarding Promenade regeneration and any future flood alleviation works, and I will continue to do so. I've had several meeting to discuss this matter. Mr Wetton is correct in his rationale regarding safety and the difficulty for Pensarn is the constantly shifting pebbles. While it's a difficulty it's not impossible to overcome.

What Mr Wetton didn't mention is the costs of such a project. It is highly unlikely that beach access would be a standalone project and this is why myself, as the Pensarn County Councillor, supported by Cllr McCoubrey and fellow members will make sure that any redevelopment or other works includes consideration and funding for a slipway or at least ramped access to the sand. There is a good example of a slipway access at Llanfairfechan where there is a short concrete slipway from their promenade and another example I've looked at in Beaumaris, Anglesey. Both, however are nothing like what would be required at Pensarn.

Ultimately I would like to have access and a facility for the hire/loan of the sea going wheel chairs that are becoming increasingly popular on coastal resorts and proper shower and changing facilities. To this end myself and my colleagues will take every opportunity to raise the profile for the need for access at Council or Placeplan meetings that include the promenade.
