a) Gwyrch Castle - Queen's Platinum Jubilee Beacon

The Acting Deputy Clerk reported that a meeting had recently been held with Trustee representatives regarding the proposed Beacon lighting, bagpiper and choir event planned for 2<sup>nd</sup> June 2022. The Trust had welcomed proposals in principle but had asked for further details.

The Committee were presented with photographs of potential locations for the event. Reference was made to possibility of using castle for burial of time capsule as part of Platinum Jubilee activities. Members suggested possible alternative locations and DEFERRED to the next meeting.

A copy of draft National Lottery Grant application associated with this event was

RECEIVED, COSIDERED and APPROVED for submission.

Cllr G Frost AGREED and was thanked for his kind offer to assist with live streaming

It was RESOLVED that the Officer report be received and possibility of amplifying music and feasibility of live streaming of the Platinum Jubilee event be progressed.

### 532/21 Gohebiaeth – Correspondence

- b) Letter from St. Kentigern's seeking grant aid and application form had been sent from office.
- c) Contractor correspondence in regards to repairs to 2 Water Street, Abergele.
- d) Heritage Blue Plaque Request

The first Archdruid of Wales, David Griffith (known as Clwydfard) 1800- 1894 lived in London house on the site of The Peculiar Gallery. A copy of correspondence circulated with agenda.

Deputy Town Clerk reported that having spoken to Conwy County Borough Council, Planning Officer, who indicated that in addition to property holders consent, any request would need assessing to see if site required planning permission and/or listed building consent.

Following debate members felt that other sites and contemporary sites should also be considered for blue plaque status, although committee was informed that any scheme would need to dovetail with the emerging Place Plan.

### **RESOLVED**

- i) That application for blue plaque for the Peculiar Gallery be supported in principle as trial exercise for expanded blue plaque scheme.
- ii) That an article regarding a future blue plaque scheme be included in a future Newsletter.

### e) Street Cleansing

A request for funding for street cleansing had was RECEIVED from the Department of Environment, Roads and Facilities at Conwy County Borough Council and copy circulated with agenda.

Committee was disappointed at the late receipt of this request (post budget setting)

and also that community was paying for street cleansing services via council tax. Reference was made to the reintroduction of small street sweeper for Abergele that may assist improving this service.

It was RESOLVED that Abergele Town Council would not be contributing £5,000 for street cleansing on this occasion.

### 533/21 I'm a Celebrity Bugs and Ghosts

Deputy Clerk sought committees steer regarding the future of bugs and ghosts features installed throughout town as part of I'm a Celebrity television programme. It was also reported that Gwrych Castle were considering introduction of a celebrity themed trail. Members suggested other locations should also be considered for display e.g. Manorafon Farm Park.

#### **RESOLVED:**

- i) That any business wishing to remove their bug/ghost be asked for a grace period to assist Council in finding a new location e.g alternative business premises to avoid lengthy storage issues.
- ii) That further investigation be undertaken regarding future display of Bugs and Ghosts.
