The Officer provided an overview of the Beach of Dreams progress to date including four "Calls to Action" on QRBoxx

- "Let us Know if you would like to participate in the Walk",
- "Let us Know what you are already doing to care for our coast",
- "Contribute to our digital gallery"
- "Make a Climate Pledge" (via WG climate action).

The group asked about the plans for the UK-wide coastal walk, and the Officer explained that Bay of Colwyn Town Council was the lead on this, with the art installation of pennants taking place on May 10th (or 11th) on the beach, in conjunction with the Prom Xtra weekend.

She further explained that Events Conwy, who was managing Prom Xtra, was also supporting Bay of Colwyn Town Council, as the lead partner with Beach of Dreams for North Wales, so the events would run in tandem. She explained that Abergele Town Council had been invited to host an informational stand at the event, so the Officer would likely be there on that date.


The group discussed the logistics of the walk, in terms of distance, timings, whether a relay was possible, and potential participants, such as the Running group. The group also asked about plans for activities at Pensarn beach on the day of the walk, and the Officer explained that she had envisioned free, low-key, family-friendly activities on the promenade, to bring people down to the beach, to see off the walkers. She explained she had used the Gwenafanc story to link into Beach of Dreams when working with the children, and she hoped to work with Men's Shed to create "dragon scales" for children to paint. The group also suggested linking in with Tesco, and borrowing a gazebo, and putting on a range of activities, including painting stones, as well as entertainment such as the one that was used at the Children's Fayre. 


Officer thought this was a lovely idea but also reminded the group also that she would be at the information stand in the Bay, and the Deputy Clerk's events schedule was full, so it was suggested by Members that they as a group, could run the activities at Pensarn Beach on the day.

The Officer then provided an overview of the process for creating the batik hand-dyed silks and showed images of previously created pennants.

Members were invited to contribute ideas, and worked to complete the memory gathering forms, as well as completing tracing and pencil drawings using printed images and canvasses brought in by a Member, for inspiration. Members shared these with the Officer for use in the submission to Beach of Dreams' resident artists and shared and / or uploaded images to QRBoxx for the digital gallery.







4. Minutes

The minutes of the previous meeting held on 15 October 2024 were **AGREED** as a correct record.

5. Creu Conwy (Regeneration Project)

The Culture Development Manager, Helen Jackson attended the meeting to provide an update on the Creu Conwy Regeneration Project.

The project delivered the shared prosperity projects through the shared prosperity fund and included various activities such as public arts, which was funded by the Brilliant Basic Scheme to install destination signage, Creu Conwy Ifanc for young people from 0-25 years old, supporting libraries as community hubs and digital improvements to libraries.

6. Abergele Western Gateway (Regeneration Project)

Sarah Murphy and David Lowe from Cartrefi Conwy attended the meeting and provided an update on the Abergele Western Gateway.

There was a discussion on the current use of the site and the proposals for the site, which was in a conservation area. It was noted that Phase 1 had been submitted for planning permission for an education facility.

Information/sharing events were planned for the public in February, 2025.

There was a discussion for a Llandrillo College representative to attend the next LAF East meeting in April, 2025 to provide an update on the current situation relating to the progress and timeframe for proposals on the site.
