

Grant Elusennol o £10,000 ar gyfer elusennau bach sy'n gweithredu yn y sector manwerthu, hamdden a lletygarwch.

- Siopau sy'n cael eu rhedeg gan elusennau
- Eiddo chwaraeon
- Canolfannau cymunedol / neuaddau pentref

Mae Llywodraeth Cymru wedi cyhoeddi y bydd elusennau bach a Chlybiau Chwaraeon Amatur Cymunedol (CASC) yn y sector hamdden a lletygarwch yn derbyn grant cymorth busnes gwerth £10,000 i'w helpu i ymateb i heriau ariannol Covid-19. Bydd y pecyn newydd hwn yn cefnogi eiddo sydd â gwerth ardrothol o £12,000 neu is.

Mae gan awdurdodau lleol ddisgresiwn i ddarparu grantiau i gyrrf dielw y maen nhw'n eu hystyried yn gweithredu at ddibenion elusennol ond nad ydyn nhw ar hyn o bryd yn derbyn rhyddhad elusennol na rhyddhad CASC. Dim ond i sefydliadau dielw sy'n derbyn rhyddhad ardrothi dewisol neu sydd â hawl iddo ac sy'n gweithredu yn y sectorau manwerthu, hamdden neu letygarwch y bydd y disgrifiwn hwn yn berthnasol.

Cafodd yr holl hysbysiadau galw eu gyrru ym mis Mawrth felly byddwch wedi cael copi, hyd yn oed os ydych yn derbyn rhyddhad ardrothi llawn. Rhaid bod yr asesiad NDR wedi bod mewn meddiant ac ar y rhestr ardrothu ar 20 Mawrth 2020.

Charity Grant of £10,000 Grant for small charities operating in the retail, leisure and hospitality sector.

This includes:

- charity run shops
- sports premises
- community centres / village halls

The Welsh Government has announced that small charities and Community Amateur Sports Clubs (CASC) within the retail, leisure and hospitality sector will receive a £10,000 business support grant to help them respond to the financial challenges of Covid-19. This new package will support properties with a rateable value of £12,000 or below.

Local authorities have discretion to provide grants to not-for-profit bodies they consider to be operating for charitable purposes but aren't currently receiving charitable relief or CASC relief. This discretion will only apply to not-for-profit organisations who are in receipt of or have entitlement to discretionary rates relief and operate in the retail, leisure or hospitality sectors.

You will need your Business Rate 9 digit reference number. This can be found in the 'your ref' section on your business rate demand. All demand notices were issued out in March so they will have had a copy, even if they are in receipt of full rates relief. The NDR assessment must have been in occupation and in the rating list as at the 20th March 2020.
