Cllr P. Heap-Williams declared a prejudicial interest for Minute no: 282/22 and retired from the meeting during that item.

Cllr D. Fetherstonhaugh declared a prejudicial interest for Minute no: 283/22 planning application 0/50004 and retired from the meeting during that item.

276/22 Visitor to the Council

John Morris, Community Speed Watch Manager at North Wales Police was welcomed to the meeting. He explained that Community Speed Watch schemes have been running for seven years and have been successful. Currently there are 46 volunteer teams.

Police provide training and loan equipment initially. A minimum of two people are required, however, in practice three are better as one person will be operating the radar and two people dealing with registration numbers: one reading the registration number aloud whilst the other notes it down. Once a Community Speed Watch Scheme has been established, the group will be expected to purchase their own equipment. John Morris estimated costs would be no more than £300 for a radar speed gun.

Speeds over 10% plus one are recorded so in a 30mph zone that would be 35mph and in a 40mph zone that would be 46mph. The data is held on a national data

base and advice letters from the Community Speed Watch to speeders. The third time a speeder is recorded, they will be sent another letter and their registration is passed onto NW Police or Go Safe team.

Members raised concerns that volunteers were doing police work and that issues occur in early hours of the morning when it was still dark.

John Morris explained that police only have limited resources. If the Community Watch Scheme identify areas and times were issues occur with traffic, the Go Safe team could make site visits. Go Safe have cameras that can operate during night. Community Schemes should only be operating during the day.

Members thanked John Morris for attending the meeting.

278/22 **Traffic monitoring (PM: 84/22)**

Members were informed that their options regarding traffic monitoring included installing a data collection function to the speed signs at an estimated cost in of £300. Alternatively, members could set up a Community Speed Watch scheme, however, this would have to be Councillor or Community led as the officers do not have the resources for such a project.

It was RECOMMENDED that Members at ATC need to take the lead on the Community Watch Scheme and engage the community. It was further RECOMMENDED to advertise for more volunteers and to get information for speed hot spots via social media and the newsletter.

Cllr A. Hunter and Cllr P. Heap-Williams indicated they would be willing to volunteer for the Community Speed Watch scheme.

It was RESOLVED that members would support the Community Watch Scheme initially; i.e. contact CWS for training and to borrow equipment. If the trial is successful then the Council to consider budgeting about £500 to buy equipment for the Community Speed Watch Scheme.

280/22 Report from Representatives

The following report from members who are representatives on outside bodies of the Town Council were RECEIVED and NOTED:

a) Cllr S. Jones-Roberts and Cllr. A. Wood, representatives on the North & Mid Wales Town Councils Forum attended the Annual meeting on 22nd July 2022.

Cllr S. Jones-Roberts RECOMMENDED that members could email her questions in advance as another meeting was going to commence in the following week. Issues to be considered on the upcoming agenda included a request for a free port in Holyhead, Health, Housing and Tourism tax.

281/22 Litter bins

The Litter and Dog bin Report conducted in 2021 was RECEIVED by members.

The Deputy Clerk explained that at the Conwy County Borough Council Town and Community Council a presentation was made by the Open Spaces Manager. Attendees were informed that CCBC no longer have internal funding for litter bins and that they would only be able to relocate bins to more suitable areas. Any requests for new bins would have to be funded by Community Councils. CCBC are willing to work in partnership with Community Councils, however, they would only do so as part of a larger scheme.

The Litter and Dog bin Report was NOTED.

282/22 I'm a Celebrity Bugs & Ghosts

Cllr. P. Heap-Williams was placed in the waiting room at this juncture and did not participate in any discussions.

Members were informed that the relevant County Borough Council Department was contacted and that no grant stipulations were attached to the model bugs and ghosts created as part of the promotion of 'I'm a Celebrity, get me out of here'.

Members were further informed that the bugs and ghosts were due for collection on 13/10/2022 and arrangements had been made with Cllr. N. Williams to access the storage facilities. The contractor only took down the spider and indicated that they would be returning over the weekend to complete the task. A vote of thanks was given to Cllr. N. Williams who agreed to store the Bugs and Ghosts at no cost to the town council.
