#### 93.22 Road Traffic Orders

a) A Road Traffic Order from CCBC relating to St. George and Abergele was RECEIVED and CONSIDERED. Members stated that they were delighted that the order was to be progressed due to the increase in traffic following the housing development, creating heavy vehicles to travel along the roads and RECOMMENDED that a letter of thanks is sent to Mr Jones on behalf of members and residents. It was RECOMMENDED to forward the following observation and request to CCBC before the deadline:

Members requested that the signage near the Tan y Gopa road entrance (near Gwrych Castle) should state that heavy traffic can only go up the road (Tan y Gopa) and not turn on to Lon Fawydd or Ffordd Tan'r Allt. Members considered that if a notice is not installed at the bottom of Tan y Gopa road that heavy goods vehicles will go up the road, before they have sight of the weight restriction notice.
