- An email from Gwynedd Pension Fund with an invite to the Fund Valuation meeting on the 26th October 2022 was RECEIVED, CONSIDERED and NOTED.
- b) (i) The Draft Independent Remuneration Panel for Wales Annual Report determinations for 2023/24 and to resolve the mandatory determination was RECEIVED and CONSIDERED.

c) A request for funding from St. Michael's Church and Canolfan Dewi Sant as part of the 'warmer places' project was RECEIVED and CONSIDERED. It was NOTED that if another religious group request funding then they should be provided the same privilege.

Cllr. Williamson explained that the purpose was to give people a place to go to keep warm during this difficult winter. St. Paul's Church, the Family Centre, Abergele Library and the Old People's Club are among the others groups to offer the service between now and next March. Men shed are also offering a cup of tea.

It was RESOLVED to APPROVE £250 for both of the organisations and if further funding is required in due course that the organisations contact the Council again in the future.

- e) An email and letter from Rialtas Finance support regarding the sale of the business was RECEIVED.
- f) An email from Abergele Camera Club with an offer for the Town Council to take ownership of the loaned display boards was RECEIVED, CONSIDERED and APPROVED.
- In accordance with the Public Bodies (Admission to Meetings Act) 1960 and with Standing Order no.68, in view of the confidential nature of the business about to be transacted, it is advisable in the public interest that the press and public be temporarily excluded and instructed to withdraw. It was RECOMMENDED to start taking a meter reading for the electric on a monthly basis and to request that a water meter is installed for the monitoring of the Town Council's water usage. The provision of ring fencing budget from the current reserves to cover the cost of utilities was DEFERRED to the next meeting.
